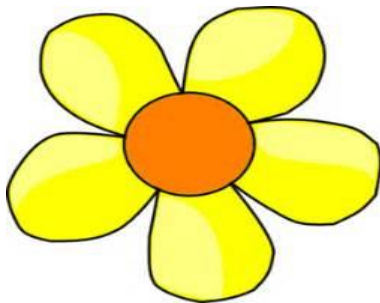
We will be starting an Auto Cad/Detailing class in May. There will also be another OSHA 30 class starting in June.
